Athene Asset Management LLC (“AAM”) serves as the investment manager for AALC and ALRe pursuant to an investment management agreement with each of AALC and ALRe. AAM Holdings, L.P. (“AAMH”) is the sole member of AAM. AAM GP Ltd. (“AAM GP”) is the general partner of AAMH. Apollo Life Assets Ltd. (“Apollo Life”) is the sole shareholder of AAM GP. Apollo Capital Management, L.P. (“Capital Management”) is registered as an investment adviser with the SEC and is the sole member and manager of Apollo Life. Apollo Capital Management GP, LLC (“Capital Management GP”) is the general partner of Capital Management. AAA Associates, L.P. (“AAA Associates”) is a Class B member of NCL Athene and thereby has the right under certain circumstances to consent to the disposition of the Ordinary Shares of the Issuer held by NCL Athene.
